In Scripture, a name is not a label — it is essence, frequency identity.

- •To be written in the Book = your genome encoded in coherence.
- •To be blotted out = your sequence deleted from the registry.

This is why Jesus promised: "I will never blot his name out of the book of life." (Revelation 3:5). Coherent entries remain. Corrupt ones are purged.

The Scroll of DNA
